Irish Wolfhound Health Group Treasurers Report Year 01/01/2011 to 31/12/2011

The year started with a balance £4508, and ended at £4549. Due to the generous donations made by individuals and profits from regional events/activities offsetting the deficit in some accounts.

Our accounts include the Project Development Fund, originally financed with a sum of $\pounds4500$ from the Club's Health Fund, this fund subsidises the heart testing & booklets and last year also the Seminar. This account started the year at $\pounds3261$. Add to this the donations of $\pounds921$, add seminar takings of $\pounds340$. The amount used from this fund in 2011 was $\pounds1080$ to prop up heart testing and the seminar leaving a balance of $\pounds3442$, surplus of £181 on the year.

The regional heart testing sessions made a loss of £239. The receipts being £7826 but cardiologist's fees & expenses slightly more at £8065.35. This does not show the true picture as the Group decided to subsidise heart testing for the over 8's, our Super Vets, with the fees covered by the PDF, this year testing 28 super veterans at a cost of £40 per dog amounting to £1120 in true terms. At some sessions, for instance Club show, Serena tested 18 hounds of which 6 were super vets true cost of £240, but due to the high number tested reducing the loss on that session to just £70. Serena will test more dogs in a day session than any other cardiologist.

We consider this money well spent and the Group are wholeheartedly in favour of continuing this subsidy, at least as long as we have the funds. These funds are greatly helped by the generous donations received.

We thought we may have to increase testing fees this year due to cardiologist fees increasing, but have decided to keep status quo, Rebecca will explain that.

The loss on the seminar amounting to £396, even though we had a good turnout and most of the food was provided free by IWHG committee. The Seminar unfortunately clashed with another giant breed seminar unknown to us until too late, and we also kept our ticket prices very low at £5 to IW owners trying to give something back to the members and friends who regularly donate to the IWHG.

The booklets are also subsidised by the PDF showing a cost of this year of £105.40 for 151 booklets to be printed plus postage and packing. As you are aware these are free to breeders and new owners.

Originally when setting up the group, the 4 breed clubs each made a donation of $\pounds 250$, so $\pounds 1000$ plus a top up of $\pounds 750$ from the 3 UK Clubs, (Ireland are no longer members) total of $\pounds 1750$ to cover admin.

2011 started with a balance of £1247, with just 1 meeting costing us room hire, another meeting at Three Cnts, nil costs. We have web hosting of £40.68 but Anne Vaudin our website manager, kindly covers the additional cost of the domain fee of £28.66. Total admin costs of £140. Balance now £1107.
